'REAL' HAUNTED PLACES IN IL

Have you ever wondered what places are actually haunted, or have you ever wanted a terrifying tour of an actual haunted place? If this has ever crossed your mind even just briefly, this article is for you. In this article we will dive into four actual proven haunted places in Illinois going over bone chilling occurrences that lead them to be considered haunted as well as the horrifying events of their past. If this is something you want to hear, read further if you dare.

Ashmore Estates

Ashmore Estates is considered one of the most haunted places in Illinois, with many paranormal investigators picking this as

their primary location. Many of the paranormal sightings include seeing full body apparitions and reports of hearing unusual things, such as screams. There has also been unexplained movement of objects followed by random cold and hot spots. But, what led to it being haunted? What led to it being haunted? Why is it such a hot spot for paranormal activity? If you want to know these things and more, continue reading here:

Originally named the Coles County Poor Farm, in 1870, the county purchased a plot of land where a brick building, known as the Almshouse. This was the original building built; the house had many residents who were referred to as inmates, many of those inmates died

here. A burial ground was said to be located north of the property, and later, a second cemetery was built on the grounds. Superintendent Johua Ricketts recorded 32 deaths out of roughly 250 “inmates” in the Almshouse. In 1902, the commissioner of boards of charity visited and wrote that there was no supervision for the “insane” and mentioned none were locked up or restrained. They also condemned the facility, stating there were vermin-infected walls, rough floors, small windows, and improper ventilation with flies all over, including in the poorly prepared food. After this, the Almshouse committee received bids for a new fireproof house in early 1915.

A HISTORY OF THE OLD STATE HOSPITAL

The Peoria State Hospital has an assortment of stories within its walls that many individuals may not be aware of. The facility itself was opened in 1902, but was originally established as the Illinois Asylum for the Incurable Insane. However, it closed its doors in 1973 due to the lack of funding and staffing issues.

Dr. George Anthony Zeller was a local surgeon who not only was the father

of the institution, but also its superintendent. Zeller believed in providing the best work for his patients, which led to some practices that were not very common at the time. He didn't believe that any patient was “incurable,” changing the name instead to Illinois General Hospital, but later on, it was changed to Peoria State Hospital.

The doctor was considered to be mad for refusing to lock up his patients. He removed bars from the doors and windows, discarded all types

of restraints and had an open-door policy with an emphasis on treating humans with respect and showing empathy for them. Dr. Zeller openly refused to tie down or lock his patients to a piece of furniture.

Even with the new, gentle practice of Dr. Zeller, the hospital itself is marked by tragedy, suffering and a presence of sorrow. After the building's closing, the Peoria State Hospital became a popular attraction for paranormal activity.

GHOSTS: WHAT?

Ghosts have fascinated people for centuries, always being a mystery. Throughout history, people have reported seeing them, and many stories and legends have been created about them. One of the most famous stories revolves around the “Conjuring” house, with its dark history and reported paranormal activity, which has inspired an entire horror franchise.

The spirits have been around far longer than any 2000s movies, though. Historically, many cultures have established beliefs in ghosts. In East Asian cultures, they fully believe in ghosts. They share beliefs about spirits and ghosts, but they have different ideas about them. Some cultures believe in hungry ghosts that can be appeased with pleasant offerings, such as items they might desire. Others focus on respecting ancestors or have various spirits linked to places. Medieval England also believed in ghosts and the paranormal, with many references to spirits wandering the land. These ghosts were often seen needing help rather than being purely frightening.

Modern science, though, has a different perspective. For instance, mold and electromagnetic fields can affect our brains in certain ways. A civil and environmental engineering professor at New York's Clarkson University, Dr. Shane Rogers, investigated the link between haunted houses and mold.

He noticed what he calls “strange behavior” from his children after there was an exposure to mold in his basement. He would also watch TV series about haunted houses and noticed that many of them had signs of mold. Many of the symptoms that people experience from mold match the ones seen in personal ghost sightings.

Samuel Spencer, a London-based freelance writer, wrote an article called “The Science Behind Seeing Ghosts.”

“According to the National Health Service, aspergillus mold, which is found in damp buildings, can cause shortness of breath and optic nerve inflammation, causing dark shapes to float across people's vision,” Spencer said.

On the other hand, electromagnetic fields can cause disturbances in people's brain signals, causing them to have hallucinations.

“There is a theory that certain sound frequencies (around 19 hertz) can cause the human eyeball to vibrate slightly, causing optical illusions.”

Regardless of scientific explanations, the phenomenon of ghosts remains a mystery. While some experiences can be explained by environmental factors, the true nature of ghosts continues to slip away from definitive answers. The lasting belief in ghosts across cultures and throughout history suggests

Within the property, Manuel A. Bookbinder is the most famous spirit, who happened to be an old patient of Zeller. The doctor would allow patients to work within their abilities. To add on, Bookbinder had the opportunity to work with the burial crew, so he did. These are the facts of Bookbinder; however, there are many conspiracy theories connected to the patient.

One story about Bookbinder tells about how he was referred to as "Ol' Book" because he used to lean up against an old elm tree in the nearby graveyard and would sob uncontrollably at each funeral, whether he knew the person or not. When

time met Ol' Book, over 300 people attended his funeral, including over 100 nurses and the infamous Dr. Zeller--who delivered his eulogy. Bookbinder's casket was set on heavy boards across the empty grave, due to him being a bigger person. Despite this, when the time came to lower him into the ground, the men pulled very hard on the ropes holding his casket so the boards could be removed, but when they did, the opposite force happened. The casket flew into the air as if nothing was inside, and all those in attendance heard weeping coming from the graveyard elm. Looking over to the tree, there was Bookbinder, standing by the elm. The

doctor insisted that the casket should be open; Bookbinder was no longer by the tree.

Throughout time, the elm began to rot, so Zeller sent someone to remove it. After a few tries, the worker returned to the doctor and informed him that every time he would hit the bark with his ax, he would hear cries, so he refused to partake any longer in the removal of the tree. Next, he had the fire department pay a visit to burn it to the ground, but that didn't work either. The chief of the department had to report back to the doctor that they had lit the tree on fire; however, they had to put it out after seeing someone crying

through the thick smoke. Throughout a couple of tries, Zeller gave up, and the tree ended up falling over on its own approximately a year later. Ever since the falling of the elm, people walking by at night, claim to hear lingering cries in the distance.

Today, both the medical and paranormal legacy of the Peoria State Hospital live on. There is now a Peoria State Hospital Museum, and the museum offers a variety of tours that explain the history of mental health care. Visitors of the museum are able to engage in paranormal tours, while also getting the historical information component. They also offer vendor bazaars and

Halloween attractions.

The attraction offers public and private paranormal tours, guiding you through popular paranormal hotspots both inside the historic buildings and in the cemeteries. The tours also provide equipment to join in on the paranormal experience, taking place from 8 p.m. to midnight. On the historical side, costumed actors are present, bringing the history to life right in front of those in attendance. Many documentaries, photos and stories are also available. For a person to set up a tour, it is best for them to go to the Peoria State Hospital website and message the owners to set up a visit to the local museum.

bids for a new fireproof house in early 1915.

Later, the contract for the new almshouse was granted to J.W. Morgan. Not much is recorded after this except that a full-time caretaker and his family took turns on the property, living separately from the inmates in an old white farm house for supervision until 1959, when Coles Counts sold the property to Ashmore Estates. The corporation opened the property as a private psychiatric ward, which closed down just five years later due to debt. The institution reopened in 1964 and changed from a private facility to one that accepted patients from state mental facilities. In 1976, the facility once again had a change of ownership, where it was converted into a more modern place and was seen to have a brighter future, but after difficulties dealing with the Public Aid and Health over funding. The facility was forced to close in 1987 after exceeding \$1.5 million in

debt. tours in the offseason.

Afterwards in 1998, the property was bought by a community member who planned to renovate it, but this was made nearly impossible and fell through due to continuous vandalism. It then sat empty until 2006, when it was bought and turned into a haunted house and used for paranormal tours in the offseason.

The Congress Plaza Hotel

The Congress Plaza Hotel, located in Chicago, has housed many influential people, including presidents, during their stay in the windy city. Still open today, many wonder if this place is haunted? Are the accounts of paranormal activity that stretch decades really true? This is up to you to decide after reading this gripping description. Many deaths have occurred at the hotel, dating back to 1900 when a Spanish war veteran took his life. Then, in 1904, just 4 years after the first death, an elevator operator died

when an elevator operator fell 70 feet down the elevator shaft to his death. Over the years, many deaths occurred, although the official number of deaths is not publicly known, it is speculated to be dozens. It is also noted that H.H. Holmes, who is more widely known as America's first serial killer, is rumored to have sought out victims in the lobby. Which would make sense since being that his “murder castle” was only a few blocks away. Al Capone supposedly also stayed there. Many people who have stayed there and in recent years have not been able to stay the night. On one occasion, two marines ran out in the middle of the night, stating there was a black figure terrorizing them in their room. Staff have also been reported to not give information about certain rooms and instead just mention they are too horrible to stay in. Things like ghostly figures, hands reaching out of the walls, strange noises, and objects moving by themselves

have been reported. So, what do you think, is the Congress Plaza hotel actually haunted, or is this all just a bunch of made-up stories that happen to occur in a place where dozens have died?

McPike Mansion

During 1869, the McPike Mansion was built in Alton IL, on 15 acres of land by architect Lucas Pfeifferberger and owned by the McPike family, where they lived till 1936. The mansion then changed hands many times since its original owner, Henry McPike. The house has been home to the Browns Business College and later on Paul Laichinger, who rented rooms out to occupants.

This home hasn't been occupied since the 1950s's the weather and vandals brought damage to the architecture of the home, the house had 11 marble fireplaces and beautifully carved stairwell banisters, which had all been stolen and sold after explorers found

the abandoned house. Since then, the newest owners, Sharyn and George Luedke. Who now have been trying to take this house back in time to when it was the best on the block.

Bachelor Grove Cemetery

In 1834 the first burial in Bachelor Grove happened, the cemetery having now over 80 tombstones though most are spares due to less upkeep and vandalism to the graves. The graveyard has more infant toys and small items scattered around the grounds some being by most of the infant graves.

The cemetery holds the hauntings of a lady walking through the graves to a farm house disappearing and more. The yard's haunting atmosphere comes from the landscape with a murky pond in the northwest corner and an overgrown chainlink fence running along some of the lands. Making this graveyard one of the most haunting hotspots in the area.

Blood Moon Manor

Located in Forest City, the first on the list is Blood Moon Manor. This one doesn't reach the same scare factor as the other ones. The

Aura

Located in Bartonville,




